While Sponsorship does afford some benefits (detailed below), the higher purpose is to help the Southeast Little League impart the values of teamwork, sportsmanship, and fair play to the children of the community, so that they may someday use these values in becoming good citizens.

Sponsorship of the Southeast Little League does not permit the Sponsor to have any rights or responsibilities in the operation of the Southeast Little League or any team in the Southeast Little League, nor does the Sponsor have any rights or responsibilities in the selection of managers, coaches or players for any team in the Southeast Little League. Nothing herein shall make us partners or joint ventures. The Sponsor and the Southeast Little League are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein.

Any reference to the Sponsorship under this agreement must make it clear that the Sponsorship is with the Southeast Little League ONLY, and NOT with Little League Baseball, the organization. Use of the marks of logos of Little League Baseball by any local sponsor is prohibited, unless permission is expressly granted in writing by Little League Baseball, Incorporated.

The Southeast Little League agrees to provide the following benefits in exchange for the sponsorship commitment:

#### Sponsorship Level

- A. Single Level (\$100): Logo on the Southeast Little League banner on the dugout fence
- B. Double Level (\$300): One 3x5 field banner with business name and/or logo
- C. Triple Level (\$500): Select the team's color and/or name. Company name or logo printed on the back of the team's jersey above the number.
- D. Home-Run Level (\$600): Select the team's color and/or name. Company name or logo printed on the back of the team's jersey above the number and company logo added to the side of the team's hat.

For the above considerations, the Sponsor donates \$\_\_\_\_\_ to the Local Little League, understanding that its donation is to benefit the entire league.
